## Subject: PROJECTED COSTS FOR THE CALIFORNIA LIFELINE PROGRAM FOR FISCAL YEAR 2025-2026 (2024-05 ADMINISTRATIVE LETTER 5)

General Order 153, Section 10.4.2, requires California LifeLine service providers to annually submit to the Communications Division a forecast of the service provider's California LifeLine claims. The Annual Cost Projection Worksheet must be filed by June 30, 2024 by service providers that intend to file reimbursement claims from the California LifeLine Fund for the fiscal year (FY) 2025-26. No reporting is required for service providers who do not plan to file California LifeLine reimbursement claims for FY 2025-26.
