VIOLATIONS

You are hereby cited with having violated section(s) of the Public Utilities (Pub. Util.) Code and a Commission General Order (G.O.) as described below. These violations occurred during the period of April 1, 2023, to August 15, 2023.

- (1) Engaged 10 employee-drivers without evidence of Workers' Compensation (WKCP) insurance coverage in effect and on file with the Commission, in violation of Pub. Util. Code Section 5378.1. [1 count];
- (2) Failed to enroll 10 employee-drivers in the Department of Motor Vehicles (DMV) Employer Pull Notice (EPN) program, in violation of Pub. Util. Code Sections 5374(a)(1)(D) & 5381, and G.O. 157-E, Part 5.02 [10 counts];
- (3) Failed to enroll 10 employee-drivers in a mandatory Controlled Substance and Alcohol Testing Certification Program for Pre-Employment Testing, in violation of Pub. Util. Code Section 5374(a)(1)(I) and G.O. 157-E, Part 10 [10 counts];
- (4) Failed to maintain records, in violation of Pub. Util. Code Sections 5381.5 & 5389 and G.O. 157-E, Part 6.01 [1 count].

STATEMENT OF FACTS

The above violations are documented in the attached Investigation Report, which consists of the carrier's records and substantiating documents obtained from other sources.

RESPONSE

You are hereby called upon to answer this citation on or before February 13, 2024. By way of such answer, you may either:

- (1) Pay a fine of \$20,000 pursuant to P.U. Code Section 5378. (Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the Commission staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, **or**
- (3) Contest this Citation by filing an Appeal. See the attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal.*"

If you fail to respond by February 13, 2024, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

INTRODUCTION

On July 28, 2023, I was assigned to investigate the operations and practices of Presidential Express Inc. (hereinafter referred to as Presidential), due to a Los Angeles International Airport (LAX) Police Department complaint alleging that Presidential was involved in unfair business practices at LAX.

VIOLATIONS

I investigated Presidential for the period of April 1, 2023, to August 15, 2023, and found violations of the following provisions of the Public Utilities (Pub. Util.) Code and a Commission General Order (G.O.):

- **Engaged 10 employee-drivers¹ without evidence of Workers' Compensation (WKCP) insurance coverage in effect and on file with the Commission, in violation of Pub. Util. Code Section 5378.1. [1 count]**

Pub. Util. Code Section 5378.1 states in part, "A statement under penalty of perjury, stating that, in its operations as a charter-party carrier, it does not employ any person in any manner so as to become subject to the workers' compensation laws of this state."

On November 21, 2023, Bezawit Dilgassa, Senior Enforcement Analyst of the Transportation Enforcement Branch (TEB) sent a Data Request letter to Uber, via the California Public Utilities Commission's (CPUC) secured Kiteworks database, requesting waybills generated by Presidential during the review period [**Attachment 1**]. Uber responded via Kiteworks, providing a spreadsheet showing Presidential has 10 employee-drivers [**Attachment 2 shows a sample of entries in a spreadsheet**]. The Commission's Transportation Licensing and Analysis Branch (TLAB) records show that Presidential has never had an active WKCP insurance policy in effect and on file with the Commission. On March 25, 2019, Presidential completed and signed a WCKP Declaration form and Driver Statement of Applicant form stating Presidential has no

employees [Attachment 3]. Transportation Licensing and Analysis Branch (TLAB records show that Presidential did not have WKCP insurance coverage as stated on their Acord Certificate of Liability Insurance dated February 13, 2023 [Attachment 4]. My investigation disclosed that Presidential operated for 24 days and completed 798 trips without evidence of WKCP insurance [Table 1 and Attachment 4].

- **Failed to enroll 10 employee-drivers in the Department of Motor Vehicles (DMV) Employer Pull Notice (EPN) program, in violation of Pub. Util. Code Sections 5374(a)(1)(D) & 5381, and G.O. 157-E, Part 5.02 [10 counts].**

Public Utilities (Pub. Util.) Code section 5374(a)(1)(D) states in part, “The applicant participates in a program to regularly check the driving records of all persons, whether employees or subcarriers, operating vehicles used in transportation for compensation.” A search of

Presidential's DMV-EPN program with requester code [REDACTED] [Attachment 5] shows Presidential has been enrolled in the program since May 25, 2016, under Levon Arakelyan. The program shows the Director, Arthur Arakelyan (hereinafter referred to as Mr. A. Arakelyan), enrolled in the DMV-EPN program on March 16, 2022, as the second driver enrolled in the program [Attachment 6]. On December 27, 2023, Uber provided confidential records showing Presidential had 10 employee-drivers that operated for 24 days and completed 798 trips without evidence of enrollment in the DMV-EPN program [Table 1, Attachment 6 and Footnote 1].

- **Failed to enroll 10 employee-drivers in a mandatory Controlled Substance and Alcohol Testing Certification Program for Pre-Employment Testing, in violation of Pub. Util. Code Section 5374(a)(1)(I) and G.O. 157-E, Part 10 [10 counts].**

G.O. 157-E, Part 10.01 states in part that, "All charter-party carrier applicants who propose to employ any driver who will operate a vehicle having a seating capacity of 15 persons or less, including the driver, must provide for a mandatory controlled substance and alcohol testing certification program for those drivers as required by the G.O. unless all such drivers are already covered by federal testing regulations."

On September 19, 2023, Presidential emailed to me a drug test for Arthur Arakelyan and Levon Arakelyan indicating that the 10 employee-drivers listed in the Uber confidential records were not enrolled in the drug consortium program [Attachment 7].

- **Failed to maintain records, in violation of Pub. Util. Code Section 5381.5 & 5389 and G.O. 157-E, Part 6.01. [1 count]**

On August 17, 2023, I sent a Data Request, via USPS-certified mail to 8019 Irvine Ave, North Hollywood, CA 90303, directing Presidential to provide its business records. The certified notification # [REDACTED] receipt was signed and returned to me on August 21, 2023 [Attachment 8]. On August 29, 2023, I sent a copy of the data request (dated August 28, 2023) via email to Presidential at [REDACTED] where I informed Arthur Arakelyan, to respond by email with the requested documentation by September 11, 2023 [Attachment 9].

On September 5, 2023, I received an email response from CM & Associates, [REDACTED] [REDACTED] stating that he was writing on behalf of Levon Arakelyan of Presidential, who no longer operates as a Charter-Party Carrier (TCP) [Attachment 10]. On September 7, 2023, I replied by email to CM & Associates, [REDACTED] and Levon Arakelyan of Presidential, stating that Presidential is responsible for responding to the data request, and I would extend the deadline until September 15, 2023 [Attachment 11].

On October 3, 2023, I received a phone call from Presidential CEO/CFO/Secretary, Arthur Arakelyan. He stated that Presidential sent me a Circuit Charge report provided by LAX, showing Presidential's trip activity. I then explained that the Circuit Charge report is insufficient and cannot be provided in lieu of waybills. Arthur stated he does not have his waybills and he does not have access to them because the waybills were stolen from his vehicle. My investigation revealed that Presidential failed to maintain the requested records.

DECLARATION

I have read the foregoing and know the contents thereof and I declare under penalty of perjury that the foregoing is true and correct, except as to those matters stated on information and belief, and to those matters, I believe to be true.


