#### **VIOLATIONS**

You are hereby cited with having violated sections of the Public Utilities Code (P.U. Code) and California Public Utilities Commission (CPUC) General Order (G.O.) as described below. These violations occurred during the period from April 26, 2024, through April 28, 2024.

- (1) Operated as a charter-party carrier without valid authority in violation of Pub. Util. Code Section 5379 [3 counts].
- (2) Failed to enroll nine (9) drivers in the Department of Motor Vehicles (DMV) Employer Pull Notice (EPN) Program in violation of Pub. Util. Code Section 5374(a)(1)(D), G.O. 157-E Part 5.02, and the California Vehicle Code (CVC) Section 1808.1 [9 counts].

#### **STATEMENT OF FACTS**

The above violations are documented in the attached Investigation Report, which consists of carrier's records and substantiating documents obtained from other sources.

#### **RESPONSE**

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before September 3, 2024. By way of such answer, you may either:

- (1) Pay a fine of \$6,000.00 pursuant to P.U. Code Section 5378. (Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the Commission staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, or
- (3) Contest this Citation by filing an Appeal. See attached document "How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal."

If you fail to respond by September 3, 2024, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

#### INTRODUCTION

On May 2, 2024, I was assigned to investigate the operations and practices of Transtyle, Inc. (hereinafter referred to as Transtyle), because Transtyle was observed operating with an expired permit at Stagecoach Joint inspection on April 25, 2024 [Attachment 1].

#### VIOLATIONS

I investigated Transtyle for the period of April 26, 2024, to April 28, 2024, and found violations of the following provisions of the Public Utilities (Pub. Util.) Code and Commission General Orders (G.O.):

Operated as a charter-party carrier after expiration of authority, in violation of Pub.
 Util. Code Section 5379. [3 Counts]

Transportation Licensing and Analysis Branch (TLAB) record shows Transtyle TCP 34935 expired on April 21, 2020 [Attachment 2]. During the Transportation Enforcement Branch (TEB) joint operation with California Highway Patrol (CHP) in Stagecoach on April 25, 2024, TEB enforcement analysts observed Transtyle operating with buses with license plate numbers , and . Enforcement Analyst Mary Sekyi-Appiah served a Cease and Desist Notice to Transtyle for operating with an expired authority [Attachment 3]. On May 8, 2024, I sent a data request to Transtyle at , with a due date of May 24, 2024, requesting PLPD insurance, workers' compensation insurance, list of subcarriers and agreement, drug consortium agreement and drivers enrolled, other fictitious business names, waybills, and random drug test results between February 1, 2024, and April 30, 2024 [Attachment 4]. On May 30, 2024, , co-owner of Transtyle, forwarded an email between Transtyle and ) discussing the number of coaches used at Stagecoach [Attachment 5].

On June 11, 2024, I emailed both owners at and at to request information on the buses that were used at Stagecoach between April 26, 2024, and April 28, 2024. On June 11, 2024, replied that 13 buses were used [Attachment 6].

On June 12, 2024, also provided information on the 13 bus drivers who worked at Stagecoach between April 26 and April 28, 2024 [Table 1 & Attachment 7].

• Failed to enroll nine (9) drivers in the Department of Motor Vehicles (DMV) Employer Pull Notice (EPN) Program in violation of Pub. Util. Code Section 5374(a)(1)(D), G.O. 157-E Part 5.02, and the California Vehicle Code (CVC) Section 1808.1. [9 counts]

In accordance with Pub. Util. Code. 5374. (a) (1) Before a permit or certificate is issued or renewed, the commission shall require the applicant to establish reasonable fitness and financial responsibility to initiate and conduct or continue to conduct the proposed or existing transportation services. The commission shall not issue or renew a permit or certificate pursuant to this chapter unless the applicant meets all of the following requirements: (D) It participates in a program to regularly check the driving records of all persons, whether employees or subcarriers, operating vehicles used in transportation for compensation.

A search of the DMV online database shows that Transtyle enrolled in the Employer Pull Notice (EPN) program under requestor code [Attachment 8]. The nine (9) drivers who worked at Stagecoach from April 26, 2024, to April 2, 2024, were not listed in Transtyle's DMV EPN program [Attachment 7 and Table 1].



The California Public Utilities Commission's (Commission) Consumer Protection and Enforcement Division (CPED) Transportation Enforcement Branch (TEB) is currently reviewing the Commission's records for intrastate transportation carriers that are regulated by the Commission.

Public Utilities Code Section 5389 authorizes the Commission and its staff to have access at any time to the land, buildings, or equipment of a charter-party carrier of passengers used in connection with the operation of its business and may inspect the accounts, books, papers, and documents of the carrier.

General Order 157-E, Part 6.01 specifically states in part that every carrier shall institute and maintain in its offices a set of records which reflect information as to the transportation services performed, including waybills, driver records, and safety and maintenance records including copies of all lease and sub-carrier agreements. Such records shall be maintained for a minimum period of three years.

Pursuant to Public Utilities Code Section 5389, the Commission is requesting a review of the Charter-Party intrastate transportation records for Transtyle, Inc. Failure to provide access to records is a misdemeanor punishable by a maximum of \$5,000, or by imprisonment in a county jail not exceeding one year, or by both fine and imprisonment, where each violation is a separate and distinct offense (Public Utilities Code Section 2110).

We are requesting that you present your documents listed below in electronic form. Please scan the following documents and email a copy to Yueting Sun at Yueting.Sun@cpuc.ca.gov by May 24, 2024.

- 1. Your current public liability and property damage insurance policy showing schedule of vehicles and drivers insured,
- 2. Your current workers' compensation insurance policy,
- 3. List of all current sub-carriers and agreements,
- 4. Current service agreement with your Drug Consortium and a list of all drivers enrolled showing dates added and/or deleted,
- 5. Other Fictitious Business Names (FBN) doing business as (dba),
- 6. Please provide the total number of trips completed from February 1, 2024, to April 30, 2024 as documented on waybills per GO 157-E, Part 3.0,
- 7. All pre-employment and random drug test results for all your drivers within the last six (6) months and
- 8. Waybills for all intrastate TCP transportation, including transportation performed as Transtyle, Inc for February 1, 2024, to April 30, 2024.

CPED reserves the right to amend, add to or revise this Data Request in the future if necessary.

Any responsive records provided by you that have been properly labeled and submitted as confidential will be treated as such under Public Utilities Code Section 583 (see also General Order 66-D). Confidential documents will not be released to the public except as required by law following a Public Records Request and reduction of confidential material.


