VIOLATIONS

You are hereby cited with having violated sections of the Public Utilities Code (P.U. Code) and California Public Utilities Commission (CPUC) General Order (G.O.) as described below. These violations occurred during the period from October 11, 2024, to October 15, 2024.

- (1) Operated as a charter-party carrier without valid authority in violation of Pub. Util. Code Section 5371 and CVC 14602.9 [1 count].
- (2) Advertised as a charter-party carrier without a valid authority in violation of Pub. Util. Code Section 5414.5 [3 counts].

STATEMENT OF FACTS

The above violations are documented in the attached Investigation Report, which consists of the carrier's records and substantiating documents obtained from other sources.

RESPONSE

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before November 4, 2024. By way of such answer, you may either:

- (1) Pay a fine of \$4,000.00 pursuant to P.U. Code Section 5378. (Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the Commission staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, or
- (3) Contest this Citation by filing an Appeal. See the attached document "How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal."

If you fail to respond by November 4, 2024, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

INTRODUCTION

On October 15, 2024, I was assigned to investigate the operations and practices of JLR Holdings LLC dba Reyes Rides Transportation (hereinafter referred to as Reyes Rides) after Reyes Rides was observed operating after revocation at Dodger Stadium on October 11, 2024. Reyes Rides' black Mercedes Sprinter van was subsequently impounded by LAPD for operating without authority [Attachment 1].

VIOLATIONS

The investigation from October 11, 2024 to October 15, 2024, disclosed violations of the following provisions of the Public Utilities (Pub. Util.) Code and a Commission General Order (GO):

• Operated as a charter-party carrier after revocation in violation of Pub. Util. Code Section 5379 [1 count].

During the Transportation Enforcement Branch (TEB) joint operation with the Los Angeles Police Department (LAPD) at Dodger Stadium on October 11, 2024, Reyes Rides' driver, was observed operating a black Mercedes Sprinter van with a license plate [Attachment 2]. Enforcement Analyst Destiny Graham interviewed the passengers on board and confirmed they paid approximately \$1,500 for the trip. The Transportation Licensing & Analysis Branch (TLAB) record showed Reyes Rides TCP 42366 permit was revoked on 8/24/2023 for failure to maintain PL&PD insurance [Attachment 3]. Destiny Graham served a Cease-and-Desist Notice and an Observation Report to employee driver [Attachment 4].

• Advertised without operating authority in violation of Pub. Util. Code Section 5414.5 [3 counts]

During the Transportation Enforcement Branch (TEB) joint operation with the Los Angeles Police Department (LAPD) at Dodger Stadium on October 11, 2024, Reyes Rides's employee driver, stated that he was driving for Reyes Rides and handed me a business card with Reyes Rides' email

address and website [Attachment 5]. On October 15, 2024, I found Reyes Rides advertising on Instagram and Yelp.com [Attachment 6].






