VIOLATIONS

You are hereby cited with having violated sections of the Public Utilities Code (P.U. Code) and California Public Utilities Commission (CPUC) General Order (G.O.) as described below. These violations occurred during the period from June 26, 2024, through June 28, 2024.

- (1) Operated as a charter-party carrier after revocation of its authority in violation of Pub. Util. Code Section 5379 and CVC 14602.9 [1 count];
- (2) Advertised as a charter-party carrier without valid authority in violation of Pub. Util. Code Section 5414.5 [1 count];
- (3) Failed to include pertinent information on a waybill in violation of Pub. Util. Code Section 5381 and General Order 157-E, Part 3.01 [1 count].

STATEMENT OF FACTS

The above violations are documented in the attached Investigation Report, which consists of carrier's records and substantiating documents obtained from other sources.

RESPONSE

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before November 19, 2024. By way of such answer, you may either:

- (1) Pay a fine of \$3,000.00 pursuant to P.U. Code Section 5378. (Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the Commission staff will deem the matter closed, or
- (2) Contact the Supervisor below to make payment arrangements, or
- (3) Contest this Citation by filing an Appeal. See attached document "How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal."

If you fail to respond by November 19, 2024, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

INTRODUCTION

On October 28, 2024, I was assigned to investigate the operations and practices of Lush Limo Coach, LLC (hereinafter referred to as Lush Limo) after the Transportation Enforcement Branch (TEB) impounded Lush Limo's Mercedes Sprinter for operating after revocation at a joint compliance inspection with the San Diego Police Department (SDPD) in San Diego on October 26, 2024.

VIOLATIONS

The investigation for October 26, 2024-October 28, 2024, disclosed violations of the following provisions of the Public Utilities (Pub. Util.) Code and a Commission General Order (GO):

• Operated as a charter-party carrier without valid authority in violation of Pub. Util. Code Section 5379 and CVC 14602.9 [1 count].

Transportation Licensing and Analysis Branch records show that Lush Limo's TCP permit (TCP 38806-B) was suspended on April 16, 2024, and subsequently revoked on July 15, 2024 [Attachment 1]. On October 26, 2024, the TEB's Field Enforcement Unit was conducting a joint compliance inspection with the SDPD in San Diego when we observed a Lush Limo Mercedes Sprinter (license plate (CDL:), and he confirmed he was conducting for-hire passenger transportation, and he gave me a copy of the waybill showing they were charging and for gratuity (for gratuity gratual)). [Attachment 2]. SDPD impounded the vehicle for operating after revocation, and the vehicle is being held for 30 days at Towing per CVC 14602.9 [Attachment 3].

• Advertised as a charter-party carrier without a valid authority in violation of Pub. Util. Code Section 5414.5 [1 count].

On October 28, 2024, I found Lush Limo advertising illegally on their website, .com [Attachment 4]. Lush Limo's TCP permit (TCP 38806) was revoked on July 15, 2024 [Attachment 1].

• Failed to include pertinent information on a waybill in violation of Pub. Util. Code Section 5381 and General Order 157-E, Part 3.01 [1 count].

My review of Lush Limo's waybill (Lush Limo Contract For Service) disclosed that it lacked the following information as required by G.O. 157-E, Part 3.01:

- 1. TCP number.
- 2. Vehicle license plate number.
- 3. Driver's name.
- 4. Time and date when charter was arranged.
- 5. Whether the transportation was arranged by telephone, written contract, or electronic communication.
- 6. Number of persons in the charter group.

TCP CLASS B CERTIFICATE

Notice of Impending Suspension for Delinquent PUCTRA Report

This is notice from the California Public Utilities Commission (CPUC) that the operating authority listed on this letter will be suspended on April 15, 2024

Reason: Failure to pay annual fees (PUCTRA)

Pursuant to California Public Utilities Code § 421, the Commission shall annually determine a fee to be paid by every passenger stage corporation, charter-party carrier of passengers, pipeline corporation, for-hire vessel operator, common carrier vessel operator, railroad corporation, and commercial air operator, and every other common carrier and related business subject to the jurisdiction of the Commission. This fee is deposited into the **Public Utilities Commission Transportation Reimbursement Account** (**PUCTRA**).

Pursuant to California Public Utilities Code § 423, every carrier and related business subject to California Public Utilities Code § 421 shall make the payments of the required fee in accordance with the following schedule:

- (a) Every carrier and related business with annual gross intrastate revenues of **one hundred thousand dollars (\$100,000) or less** shall make payment of the fee to the commission on an annual basis on or before January 15.
- (b) Every other carrier and related business not subject to subdivision (a) shall make payment of the fee on a quarterly basis between the first and 15th days of July, October, January, and April.

In addition, each carrier and related business must prepare and transmit a report, called a "PUCTRA Report," showing the gross intrastate operating revenue of the carrier or related business together with the fee established pursuant to California Public Utilities Code § 421.

Pursuant to California Public Utilities Code § 405, if any person or corporation is in default of the preparation and submission of any required report or the payment for a period of 30 days or more, the Commission may add to the amount of that estimated fee a penalty not to exceed 25 percent of the amount owed.

"Gross intrastate revenue" includes all compensation for the transportation or storage of property or the transportation of persons when both the origin and destination of the transportation or the performance of the service is within this state, and shall not include compensation for the transportation of persons or property in interstate or foreign commerce or the transportation of vehicles by ferries."

SUBMITTING YOUR PUCTRA REPORT OF GROSS INTRASTATE REVENUE IS REQUIRED EVEN IF NO REVENUE HAS BEEN EARNED DURING THE REPORTING PERIOD. SUBMITTING YOUR PUCTRA REPORT IS STILL REQUIRED EVEN IF NO FEES ARE DUE. IT IS STILL REQUIRED TO BE SUBMITTED DURING A PERIOD OF VOLUNTARY SUSPENSION.

You must submit your required PUCTRA Report, and any accompanying fees if due, using your CPUC Transportation Carrier Portal Account. To access your account, visit: https://tcportal.cpuc.ca.gov/s/login/. For assistance, visit the Help/FAQ page: https://tcportal.cpuc.ca.gov/TCP/s/help-faqs

This is notice from the California Public Utilities Commission (CPUC) that the TCP CLASS B CERTIFICATE listed on this letter is suspended.

After the cancellation or revocation of a permit or certificate, or during the period of its suspension, or after the expiration of its permit or certificate, it is unlawful for a Passenger Stage Corporation (PSC) or a Transportation Charter-Party carrier (TCP) of passengers to conduct any operations as a carrier. (California Public Utilities Code §§ 1045, 5379). Unlawful operations are subject to fines and penalties as set forth in the California Public Utilities Code and may include permanent revocation of your operating authority or being permanently barred from receiving an operating authority.

A carrier whose certificate or permit is suspended due to failing to pass a vehicle inspection by the California Highway Patrol (CHP) (California Public Utilities Code § 5378.5, Commission Resolution TL-18336) may obtain a reinspection of its terminal and vehicles by the CHP by submitting a written request for reinstatement to CPUC and paying a reinstatement fee of one thousand dollars (\$1,000). (California Public Utilities Code § 5378.5(b)). Upon receipt of a written recommendation from CHP to suspend a carrier's operating authority, a carrier may request a hearing of the suspension by making a written request to CPUC and the CHP showing cause why the suspension should not be continued.

If your suspension is due to failing to maintain insurance, you must contact your insurance provider to reinstate your policy on-file with the CPUC.
