VIOLATION

You are hereby cited with having violated sections of the Public Utilities Code (P.U. Code) and California Public Utilities Commission (CPUC) General Order (G.O.) as described below. These violations occurred during the period from June 9, 2024, through November 1, 2024.

- Operated without valid authority in violation of Public Utilities Code Section 5379 [1 count].
- (2) Operated without enrolling a driver in their Department of Motor Vehicles (DMV) Employer Pull Notice (EPN) Program account in violation of Public Utilities Code Section 5374 (a)(1)(D) and General Order 157-E, Part 5.02 [1 count].

STATEMENT OF FACTS

The above violations are documented in the attached Investigation Report, which consists of carrier's records and substantiating documents obtained from other sources.

RESPONSE

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before December 24, 2024. By way of such answer, you may either:

- Pay a fine of \$2,000.00 pursuant to P.U. Code Section 5378. (Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the Commission staff will deem the matter closed, or
- (2) Contact the Supervisor below to make payment arrangements, or
- (3) Contest this Citation by filing an Appeal. See attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal.*"

If you fail to respond by December 24, 2024, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

INTRODUCTION

On June 18, 2024, Enforcement Analyst Pamela Wu was assigned to investigate Star-Dust Tours, Inc. (hereinafter referred to as Star-Dust Tours) because Star-Dust Tours was observed operating with an expired authority at the Disneyland Toy Story parking lot on June 9, 2024 [Attachment 1].

VIOLATIONS

The investigation from June 9, 2024, through November 1, 2024, disclosed violations of the following provisions of the Public Utilities (Pub. Util.) Code and Commission General Orders (GO):

• Operated as a charter-party carrier without valid authority in violation of the Public Utilities Code section 5379 [1 count].

The Transportation Licensing and Analysis Branch's (TLAB) records showed that Star-Dust Tours' operating authority permit expired on May 28, 2024 [Attachment 2]. Employee driver many was operating a vehicle with license plate number many on June 9, 2024, at the Disneyland Toy Story Parking lot. Enforcement Analyst Mary Sekyi-Appiah served the Inspection Observation Report to many was a who acknowledged and signed it.

On October 11, 2024, Enforcement Analyst Pamela Wu sent a data request to Frank Gonzalez, owner of Star-Dust Tours, via email at , requesting a copy of the waybill for June 9, 2024 [Attachment 3]. After reviewing the requested records, Enforcement Analyst Pamela Wu confirmed that Star-Dust Tours operated with an expired operating authority permit. The waybill reflects that the employee driver, , , picked up a Grad Night group at , , with a Yard

Time of 8:30 AM, Spot Time of 9:30 AM, and End Time of 3:00 AM on June 9, 2024 [Attachment 4].

• Operated without enrolling a driver in their Department of Motor Vehicles (DMV) Employer Pull Notice (EPN) Program account in violation of Public Utilities Code Section 5374 (a)(1)(D) and General Order 157-E, Part 5.02 [1 count].

Star-Dust Tour's employee driver, **Star-Dust**, was observed operating at the Disneyland Parking Lot on June 9, 2024. Enforcement Analyst Pamela Wu looked up the carrier's requester code, **Star-Dust**, in the Department of Motor Vehicle Employer Pull Notice (DMV EPN) program, and the employee driver, **Star-Dust**, was not enrolled in the program **[Attachment 5]**.



This is notice from the California Public Utilities Commission (CPUC) that the operating authority listed on this letter expired effective May 28, 2024.


