### Purpose:

The purpose of the Phase 4 Track 2 Technical Working Groups (TWG) is for parties to present on and discuss data templates, which would be required to be filed with a Risk Assessment and Mitigation Phase (RAMP) and General Rate Case (GRC) Application. RAMP and GRC filings are complex and cover hundreds of program areas and related risk mitigations, risk scores, and other information. The TWGs will allow for open discussion regarding what should be the information requirements and format of the templates. In preparation for the TWGs, parties were asked to develop an Excel-based data template as well as a PDF-based template guideline document. The guideline document includes the field name, field description, and field value constraints for each variable in the party's draft data template. During the TWGs, each party will present on why the utility should include this data in its RAMP and GRC Applications.

### Expected Outcome:

Workshop attendees will provide feedback on each party's data template as well as discuss the benefits and costs of various information and formatting requirements that the Commission should consider in the RAMP and GRC data templates.
