Second Amended Report of Summary of Balancing Accounts

For

Class A and B Water Investor-Owned Utilities

For the Six-Month Period Ending December 31, 2023

This is the Second Amended Report¹ to the First Amended Report from Class A and B's Water Investor-Owned Utilities Balancing Accounts as of December 31, 223. Updates to the Second Amended Report are shown as highlighted in this report.

Semi-Annual Balancing Account Report on the status of balancing accounts² for the Class A and B Water Investor-Owned Utilities (IOU) for the six-month period ending December 31, 2023. Pursuant to Public Utilities Code §792.5 (c), the Commission is to maintain an inventory of all Class A and B large Water IOUs' balancing accounts.

Summary

The total number of balancing accounts for Class A Water IOUs is 111, an increase of 2 balancing accounts from the number of accounts in the First Amended Report as of June 30, 2023, report (see Table 1).

The total number of balancing accounts for Class B Water IOUs is <mark>25</mark>, an increase of one from the First Amended Report as of June 30, 2023, report (see Table 1). In addition, the following reporting requirements as specified in the Public Utilities Code §792.5 (e) are included for all the Class A and B water utilities:

- 1) Balancing accounts with a Semiannual-end balance with more than a 10-percent differential from the balancing account's authorized revenue amount (Table 2).
- 2) Balancing accounts with an authorized revenue amount that is in the 25th percentile of all balancing accounts (Table 3).
- 3) Balancing accounts that have experienced volatile fluctuations in their semiannual balances over time (Table 4).
- 4) Balancing accounts that have not been reviewed in the previous three years (Table 5).

¹ California Water Service Company finalized analysis on four balancing accounts conditional on adopted 2023 figures of its General Rate Case proceeding (Application A.21.07.002; Decision D.24-03-042, issued March 7, 2024).

² The balancing accounts names of all the accounts are listed at the end of the report in Table 6.

Liberty Apple Valley Water Company opened the following account.

• The Drinking Water Fees Balancing Account, approved via Advice Letter 278³, effective December 15, 2021.

California American Water Company opened the following account,

• The Drinking Water Fees Balancing Account-All Districts, approved via Resolution W-4998 and AL 1428, effective December 15, 2021. The report shows zero balances on the last two reports, June 30, 2023, and December 31, 2023, and this account has no collection.

California Water Service Company opened the following three accounts:

- Pension 2021 GRC (PCBA 5), authorized in D24-03-042 for the test year beginning January 1, 2023, an advice letter is pending.
- Health Cost 2021 GRC (HCBA 5), authorized in D-24-03-042 for the test year beginning January 1, 2023.
- Drinking Water Fees Balancing Account approved via AL-2497-A, effective December 16, 2021.
- The account, Conservation 2021 (CEBA 5) was not counted in error in the First Amended Report. This account is now listed and included in tables 1 and 6 (Page 20) of this report.

Golden State Water Company closed the following two accounts:

1) Randall-Bold Balancing Account.

2) Bay Point (HSWTP) hill street water treatment facility.

• Golden State Water Company also opened the Drinking Water Fees Balancing Account via Advice Letter 1912-A, effective December 7, 2021.

Great Oaks Water Company closed the following five accounts:

- 1. Recovery of Monterey WRAM Amortization AL 290-W, previously named Multiple Balancing Account Recovery,
- 2. Recovery of Monterey WRAM Amortization AL 293-W, previously named Recovery of Monterey Style WRAM Account,
- 3. Recovery of Monterey WRAM Amortization AL 294-W, previously named Recovery of Monterey -Style WRAM Account,
- 4. Recovery of Monterey WRAM Amortization AL 298-W
- 5. Recovery of M-WRAM Amortization AL 305-W

³ The Drinking Water Fees Balancing Account (DWFBA) was approved for all class A Water IOUs in Resolution W-4698 and via Advice Letter as stated for each utility, except for San Gabriel Valley Water Company that requested to establish a new DWFBA via Advice Letter 594. The effective date of San Gabriel Valley's Advice Letter 594 is on January 1, 2024. The purpose of the DWFBA is to track the difference between all actual drinking water fees charged by the State Water Resources Control Board and the drinking water fees authorized in rates.

• At the same time, Great Oaks Water Company also opened the Drinking Water Fees Balancing Account (DWFBA) via Advice Letter 321, effective November 29, 2021.

Liberty Park Water Company lists the following account with a zero balance:

• 2020 WRAM/MCBA-Zero Balance

Liberty Park Water Company also opened the Drinking Water Balancing Account via Advice Letter 339, effective December 15, 2021.

San Jose Water Company (SJWC) opened the Drinking water Fees Balancing Account via Advice Letter 602A, effective December 15, 2021. SJWC erroneously submitted the balance for its WRAM BA as -\$16,704,478 as this was the balance as of June 30, 2023. The correct balance as of December 31, 2023, was to be -\$9,835,905 and is now corrected here and in SJWC's report as of June 30, 2024.

Suburban Water Systems (SWS) failed to include information regarding various balances of two balancing accounts, the Drinking Water Fees Balancing Account and the Sativa Production Cost Balancing Account. The Water Division requested to report on the balances to SWS and these are now included in this second amended Report.

Drinking Water Fees Balancing Account

SWS filed on December 5, 2023, the Drinking Water Fees Balancing Account via Advice Letter 395, effective December 10, 2021. However, SWS omitted this account and its balance on this report as of December 31, 2023. Water Division requested to SWS to submit a revised report including the Drinking Water Fees Balancing Account and its respective balance. SWS filed a revised report as December 31, 2023, including its balance as of June 30, 2023. The Water Division's Report on Balancing Accounts as of December 31, 2023, did reflect the Drinking Water Fees Balancing Account and its respective balance but not the earlier balances. Therefore, the Water Division asked SWS to report on the balances for the missing dates. SWS responded that the balances of this balancing account as of December 31, 2021, is an amount of \$0, as of June 30, 2022, is an amount of \$0, and as of December 31, 2022, is an amount of \$35,748.

Sativa Production Cost Balancing Account

SWS also failed to include in its last reports its Sativa Production Cost Balancing Account. Although SWS had filed on December 19, 2023, the Sativa Production Cost Balancing Account via Advice Letter 399, effective December 22, 2022, this balancing account was omitted in the reports covering the period from December 31, 2022, through June 30, 2024. At the request of the Water Division, SWS submitted an update to its reports as of December 31, 2023, and June 30, 2024. The Second Amended Report update now includes the Sativa Production Cost Balancing Account and its balances. However, the Water Division also asked SWS to also report on the balances for the missing dates. SWS responded that the balances for the reports as of December 31, 2022, is an amount of \$0 and the balance as of June 31, 2023, is an amount of \$0, respectively.

Alisal Water Corporation dba Alco Water Service began tracking costs on its Water Quality Expenses Balancing Account in this report as of December 31, 2023. Alisal had zero balances in this account since the year 2017. This account was not counted in error in the First Amended Report. Therefore, Alisal has a total of five balancing accounts shown in this amended report for December 31, 2023, and the June 30, 2024, report. **Table 2.** Balancing accounts with a semi-annual ending balance with more than a 10-percent differential from the balancing account's authorized revenue amount.⁴

Amended Report of Summary of Balancing Accounts

For the Six-Month Period Ending December 31, 2023

This is an amended report for Class A and B's Water Investor-Owned Utilities Balancing Accounts as of December 31, 2023.¹ Updates to this report are highlighted in yellow.

Semi-Annual Balancing Account Report on the status of balancing accounts² for the Class A and B Water Investor-Owned Utilities (IOU) for the six-month period ending December 31, 2023. Pursuant to Public Utilities Code §792.5 (c), the Commission is to maintain an inventory of all Class A and B large Water IOUs' balancing accounts.

Summary

The total number of balancing accounts for Class A Water IOUs is 109, an increase of 2 balancing accounts from the number of accounts in the June 30, 2023, report (see Table 1).

The total number of balancing accounts for Class B Water IOUs is 24, no change from the June 30, 2023, report (see Table 1). In addition, the following reporting requirements as specified in the Public Utilities Code §792.5 (e) are included for all the Class A and B water utilities:

- 1) Balancing accounts with a Semiannual-end balance with more than a 10-percent differential from the balancing account's authorized revenue amount (Table 2).
- 2) Balancing accounts with an authorized revenue amount that is in the 25th percentile of all balancing accounts (Table 3).
- 3) Balancing accounts that have experienced volatile fluctuations in their semiannual balances over time (Table 4).
- 4) Balancing accounts that have not been reviewed in the previous three years (Table 5).

The utility responses to the reporting requirements are listed in Tables 2 through 5 of this report. Positive dollar amounts indicate over collected balances and negative dollar amounts in red text indicate under collected balances.

¹ California Water Service Company finalized its analysis on four balancing accounts based on adopted 2023 figures from its General Rate Case proceeding (Application A.21.07.002; Decision D.24-03-042, issued March 7, 2024).

This is the Semi-Annual Balancing Account Report on the status of balancing accounts¹ for the Class A and B Water Investor-Owned Utilities (IOU) for the six-month period ending December 31, 2023. Pursuant to Public Utilities Code § 792.5 (c), the Commission is to maintain an inventory of all Class A and B large Water IOUs' balancing accounts.

Summary

The total number of balancing accounts for Class A Water IOUs is 109, an increase of 2 balancing accounts from the number of accounts in the June 30, 2023, report (see Table 1).

The total number of balancing accounts for Class B Water IOUs is 24, no change from the June 30, 2023, report (see Table 1). In addition, the following reporting requirements as specified in the Public Utilities Code §792.5 (e) are included for all the Class A and B water utilities:

- 1) Balancing accounts with a Semiannual-end balance with more than a 10-percent differential from the balancing account's authorized revenue amount (Table 2).
- 2) Balancing accounts with an authorized revenue amount that is in the 25th percentile of all balancing accounts (Table 3).
- 3) Balancing accounts that have experienced volatile fluctuations in their semiannual balances over time (Table 4).
- 4) Balancing accounts that have not been reviewed in the previous three years (Table 5).

The utility responses to the reporting requirements are listed in Tables 2 through 5 of this report. Positive dollar amounts indicate over collected balances and negative dollar amounts in red text indicate under collected balances.
