The Safety and Enforcement Division (SED) of the California Public Utilities Commission reviewed the Southern California Gas Company's (SCG) and San Diego Gas and Electric Company's (SDG&E) response letter dated September 7, 2018 regarding the identified issue in the General Order (GO) 112-F Construction Safety Assurance Inspections of Southern California Gas Company's (SoCalGas) and San Diego Gas and Electric Company's (SDG&E) Pipeline Safety Enhancement Plan (PSEP) was conducted from November 13 – 17, 2017 and March 19 – 23, 2018.

A summary of the inspection findings documented by the SED, SCG's response to the findings, and SED's evaluation of SCG's response to each finding and recommendation outlined in the attached summary of inspection findings.

Summary of Inspection Findings Pipeline Safety Enhancement Program Inspection November 13-17, 2017 and March 19-23, 2018

SED's Recommendation

SED reviewed construction records of completed PSEP projects and field verification of selected projects to validate if Sempra has conducted Quality Assurance (QA) and Quality Control (QC) monitoring and inspections as outlined in its PSEP Standard Procedures SP-1101 (Quality Plan for PSEP). SED recommends that Sempra conduct and document all unannounced field inspections of all its PSEP construction projects in order to verify that all construction activities and processes are performed in accordance with the spirit and letters of the QA/QC Plan.

RESPONSE:

SoCalGas and SDG&E support SED's recommendation to conduct and document unannounced field inspections in addition to the announced field inspections they already conduct. The Gas Compliance Quality Management (GCQM) will select, prioritize and conduct unannounced field quality assessments based on the PSEP Construction 30-Day Look Ahead Schedule. GCQM will select projects that are actively in construction and have daily observable covered tasks as listed in the construction activities column in the PSEP Construction 30-Day Look Ahead Schedule. Unannounced PSEP field inspections will be conducted without prior notice given to the respective Construction Manager. Projects will be assessed using the standardized PSEP Field Quality Assessment template which is documented digitally. PSEP Standard Procedures SP-1101 will be revised to provide for this procedure.

SED's CONCLUSION:

SED has reviewed SoCalGas' (SCG) and San Diego Gas and Electric Company's (SDG&E) response and accepts the corrective actions that it has articulated and implemented. However, SED may review the records of the corrective action during future inspections.
