

Item # 8 [14870] – 2017 Bridge Funding for Pacific Gas and Electric Company, San Diego Gas & Electric Company and Southern California Edison Company (SCE) Demand Response Programs and Activities including SCE Activities to Help Mitigate the Aliso Canyon Gas Leakage

#### PROPOSED OUTCOME :

- Approves, with revisions, Southern California Edison Company's (SCE) Proposal to Mitigate the Aliso Canyon Gas Leakage.
- Authorizes the elimination of the demand bidding program beginning in 2017 for Pacific Gas and Electric Company (PG&E) and San Diego Gas & Electric Company (SDG&E) and in 2018, for SCE (part of Aliso Canyon mitigation efforts).
- Authorizes PG&E, SDG&E, and SCE to hold a demand response auction in 2017, with revisions.
- Authorizes PG&E to increase incentives for the Capacity Bidding Program.
- Denies SDG&E's request for the proposed Armed Forces pilot but encourages development of another Armed Forces focused pilot.
- Directs PG&E, SDG&E and SCE to implement Automated Demand Response Programs with specific and uniform parameters.
- Authorizes SCE to continue its Aggregator Managed Portfolio program contracts for one additional year, but with no new negotiations.

#### **SAFETY CONSIDERATIONS :**

 The performance and funding of demand response programs ensure the reliability of electric service in the PG&E, SDG&E and SCE service territories; similarly adopting and funding demand response programs in the areas affected by the Aliso Canyon gas leakage helps to mitigate the effects of the leakage.

#### ESTIMATED COST :

- PG&E -- \$55.29 million for 2017 demand response programs
- SDG&E -- \$22.3 million for 2017 demand response programs
- SCE -- \$50.28 million for 2017 demand response programs plus
- \$9.3 million in 2017 demand response incremental funding for Aliso Canyon mitigation

#### **PROPOSED OUTCOME :**

 Approves funding for the public housing infrastructure grant applications of San Bernardino for its Lynwood and North E Street projects, Community Housing Works for its Northwest Manors II projects, and from Eden Housing, Inc. for its Hayward Senior, Warner Creek, Jasmine Square, Monticelli, Rancho Park, Royal Court, Wheeler Manor 650 5th Street Wheeler Manor 651 6th Street projects from the California Advanced Services Fund Broadband Public Housing Account Infrastructure Grant Program in the amount of \$239,793. All 12 projects were challenged by two Internet Service Providers based on services already being available within the building. This Resolution denies these challenges and modifies the Expedited Review Criteria in Decision 14-12-039, Appendix B, delegating to Communication Division staff the authority to approve applications through expedited review for properties that are wired.

#### **SAFETY CONSIDERATIONS :**

• The deployment of affordable broadband in public housing will improve access to government and e-health services, which improves safety.

• \$239,793.

## **CASF Public Housing Infrastructure Program**

- Public housing program provides grants to publicly supported housing communities to build infrastructure within the properties.
- Staff can approve applications meeting expedited review criteria.
- Approximately 360 project applications received.
- Project challenges received verifying existing broadband service/wired status; however expedited review criteria (est. in D.14-12-039) do not address this.
- Nearly all applications received are for housing facilities that already have access to broadband services and have wired units.
- Subscriptions are low.





## **Rule Clarification Needed**

- Is the CASF Public Housing Infrastructure Program
  - 1. Limited to **providing inside wire** that connects to a service provider network **where it does not already exist**, or
  - 2. Allowed to overbuild existing inside wires to **make broadband more affordable** (or free) to people in public housing?
- P.U. Code Section 281(h)(3) and Decision state that an entity is eligible if it has not denied access to any provider that is willing to connect a network to the facility.
- Resolving challenged projects via resolution is cumbersome.





## **Resolution T-17515 Summary**

- Provides staff authority to approve projects that have existing broadband service/wired status by modifying the expedited review criteria.
- Provides funding to 12 projects that fit that criteria.
- Denies the challenges by two Internet Service Providers of 12 projects that argued their services are already available and buildings are already wired.
- Modified criteria will speed up staff review to encumber monies by EOY 2016.







### **Executive Order B-37-16 – May 9**

"Making Water Conservation a California Way of Life"

- Use water more wisely
  - Adjust emergency regulation through January 2017
  - Develop a proposal to achieve mandatory reductions in urban water use by January 2017

     Building off 25% reduction / lessons learned in 2016
     5 member Agency team, including the CPUC
- Eliminate Water Waste
- Strengthen local drought resilience
- Improve agricultural water use efficiency





## **SWRCB Emergency Regulations – May 18**

- Added Sec. 864.5 Self-certification of supply reliability
  - Report conservation standard to the Board
     –Retailers by June 22, 2016
     –Wholesalers by June 15, 2016
    - » Aggregate conservation standards; requires full agreement
- Otherwise, comply with existing conservation standards.
- Water waste prohibitions continue; runoff, irrigation after rainfall, washing of driveways, etc.
- Effective June 1, 2016.





### Resolution 5103 - June 23, 2016 Agenda

#### – Option A

- Comply with SWRCB Resolution 2016-0029
- Self-certify conservation standard or continue existing conservation requirement.
- Enforce permanent water use restrictions
- Comply with reporting requirements
- Option B
  - Self-certify conservation standard or continue existing conservation requirement <u>whichever is more restrictive</u>.
  - Enforce permanent water use restrictions
  - Comply with reporting requirements
