Order Instituting Rulemaking to Consider Authorization of a Non-Bypassable Charge to Support California's Wildfire Fund.

Ratesetting

**Comr Rechtschaffen - Judge Doherty** 

PROPOSED OUTCOME:

- Finds Commission has authority to impose a Wildfire Fund non-bypassable charge.
- Approves a revenue requirement for the Wildfire Fund non-bypassable charge to collect either \$497,800,000 or \$902,400,000 annually through 2035, depending on Pacific Gas and Electric Company's (PG&E) eligibility to participate in the Wildfire Fund.
- Finds that a Wildfire Fund non-bypassable charge to collect the authorized revenue requirement is just and reasonable.
- Adopts Rate Agreement with Department of Water Resources.

#### **SAFETY CONSIDERATIONS:**

- No direct safety impacts.
- Decision finds that it does not create a disincentive for safe utility operations.

#### **ESTIMATED COST:**

Either \$497,800,000 or \$902,400,000 annually through 2035, depending on PG&E's eligibility to participate in the Wildfire Fund.

## **Shasta County Broadband: Challenges & Solutions**

#### **Challenges:**

- 7,330 Households unserved by broadband (10.1% of county)
  - Broadband at state definition ≥ 6 Mbps down / 1 Mbps up
- 20,230 Households unserved by broadband (28.0% of county)
  - Broadband at federal definition ≥ 25 Mbps down / 3 Mbps

#### **Solutions:**

- \$53.4 million in state (CPUC CASF Program) investments (2009-2017)
- \$8.25 million in federal (FCC CAF II) investments (2016 2028)
- State and Federal program support going forward





### **Shasta County Broadband Availability**

- AB 1665 Set the Goal of 98% Households Served by each Consortium Region by 2022
- Consortium for the Region is the Northeastern California Connect Consortium (NECC)






